

2 Minutes of last meeting:

5 Ideas for the Future: The Newsletter

A discussion was held on the proposal to distribute the newsletter by email. A rough calculation indicates that for a similar cost of 500 copies of a black and white newsletter, if 300 agreed to receive by email we could do 200 colour copies. It would have to change format from A5 booklet to A4

In favour: Good publicity for the Society. Reduces the load on the Road Reps. All members on email could receive the minutes. All members on email could receive updates in between meetings.

Against: Fewer people may read it (getting lost in other emails; not easily available to other family members; more difficult to read on the screen). There is benefit in the personal contact with members by Road Reps. Worth doing on paper once a year to publicise the Society to non-members.

6 Community Projects

Leslie T asked members to continue to think of ideas.

7 PLANNING ISSUES:

7a Bromley (East) Applications: (Clive Lees)

The planning officer, East, had to leave early but submitted a written report in advance of the meeting.

10 Crab Hill: Originally the application was to fell two trees but following DNA testing, it was found that one tree was not implicated in the subsidence of the property next door. At the council meeting just before our meeting, the decision to cancel the TPO and so allow the second tree to be felled was deferred pending a full independent review for which the council will pay.

Billingford: The appeal against the refusal of planning permission is in progress.

Italian Villa: The Appeal of the application to internally split the property into two separate dwellings plus an office space has been dismissed. The principal reason for this was that the overlooking by unfamiliar office staff on to neighbours would have been unacceptable.

35 D Highland Road: The appeal for the oversized fence is currently in progress. Whilst the fence looks much better now it is painted brown, in the end Clive did object on the basis that a fence this high would set an unwelcome precedent in the street.

Harcourt House, Grasmere Road: This property is up for sale at £1.5m. There have been planning applications for this site in the past and we will be monitoring the situation carefully, particularly as this is a locally listed building.

- **7b** Bromley (West) Applications: (Mike Mielniczek) Nothing to report
- 7c Lewisham Applications: (Mike Mielniczek)

Mike was unable to attend the meeting owing to ill health but submitted a written report in advance of the meeting.

44, 46 Bromley Hill: On the application to redevelop two semi-detached houses adjacent to the parade of shops to a 7 apartment block, representation against the reapplication has been made. Awaiting outcome.

Site G western side of the High Street from the Churchill Theatre down to Bromley South Station, is defined on the Area Action Plan adopted in 2010. On 25th July a meeting was held by Bromley Civic Society where the Council gave an update following the selection of a developer. Mr Kevin Munnerly said that Muse Development Ltd (from a shortlist of one!) had been given an exclusive agreement for 12 months to work on indicative phasing and a master plan to show financial viability, boundaries, land required and timetable. Land acquisition is at least 30 months away and development would then take 3 years. Large number of residential, retail and business properties are potentially affected. Meetings and consultations will be planned. The overall aim is to improve the town centre to compete with Stratford and Bluewater.

7d Joint Working Party for Beckenham Place Park: (Leslie Tucker)

The last meeting was held on 18th July. A more upbeat meeting than for many years with the news that two applications will be made to the Heritage Lottery Fund, who have visited. Total of up to £10m. for Park enhancements and for repairs to Mansion and Homesteads. The preliminary bids to be made by Feb 2014 and, if successful, followed by a second round detailed bid. Work could start late 2015 if all stages approved.

8 Transport Issues: No rep at present.

Bromley Avenue: At the junction with Grasmere Road, the yellow line only extends a short way into Bromley Avenue on the north side, leading to cars parking dangerously close to the junction. This was referred to the council who have agreed to extend the yellow line. The long awaited yellow line in Oaklands Road opposite the Mission Care Home will now go to a two week consultation with local residents.
