Bromley Town News

Glassmill Pond Restoration Project Update

Originally, Glassmill Pond and the River Ravensbourne were separate waterbodies. However, in 1955 the river was diverted to flow through Glassmill Pond with the aid of two weirs at the inflow and outflow points. This seemed good at the time, but the connection between Glassmill Pond and the River also brought some challenges such as flood risk and barriers for wildlife to thrive.

Fast forward to today, Thames 21 and its partners have been able to separate the water bodies again. The project involved the separation of the mill pond from the main channel with a bund (a barrier). The mill pond has been desilted, and the newly independent river channel now carries sediment down the river, helping to slow down the rate of siltation on the pond and maintaining its depth.





Details of the work done to date and further improvements planned during this decade are here.

Shortlands Station

In December, 2023, Network Rail sent a letter to residents living near Shortlands station, providing information about the planned works to provide step-free access. A copy of the letter is on our website <u>here</u>.

They followed up the letter by delivering an information session at Shortlands Station on 18th December concerning the plans.


Bromley Environment Network

Planning

Congratulations go to our Planning Officer, Clive Lees, who has been awarded the Wilkinson Cup by Bromley's Environment Awards committee. The cup is awarded to those individuals who have made an outstanding contribution to planning in their communities.

Cllr Anthony (known as Tony) Wilkinson was a very long-serving Councillor in what was then known as Martins Hill and Town Ward (now essentially Bromley Town Ward). He is believed to have been first elected in 1968 and remained until 1994 when he was defeated by the Liberal Democrats.

Cllr Wilkinson returned to the Council four years later, this time as a Councillor for Copers Cope Ward with former Cllr Russell Mellor. He remained a Councillor until 2006. He was Chair of the Development Control Committee for about 14 years. The Wilkinson Cup dates from his time in office.

Crime and Safety

Shortlands and Park Langley Safer Neighbourhood Ward Panel (SSNWP)

This open Panel meets every 2 months to receive an update from the local Safer Neighbourhood Police Team (SNT) covering recent criminal activity and to discuss general community and crime issues. Agendas for the meetings and minutes thereof are produced by the Panel Secretary and distributed by the Chair, Graham Pyefinch. If you would like to receive copies of the correspondence and/or join the Panel as a group representative please contact Graham on graham658@hotmail.com giving your name and address and contact telephone number as well as the group you would represent, be it your neighbours, street or other Ward group.

Graham also distributes a fortnightly update of local Police SNT crime statistics and Police/Bromley Trading Standards advice on avoiding new types of criminal activity, scams and other relevant information. The most important part residents can play is to inform the Police immediately if a crime is going on, or there is suspicious criminal activity, by calling 999. If criminal activity has passed, then call 101 or enter details on the Met Police website (www.met.police.uk). This vital information helps the Police to build up local intelligence and to take appropriate action whenever possible.

Bromley Neighbourhood Watch Association (BNWA)

Members of Bromley Neighbourhood Watch are volunteers who work with neighbours, Police and Bromley Council, encouraging people to be vigilant (not nosey) and, by sharing crime prevention tips, to help reduce crime. For more information see their website: https://bnwa.co.uk/

If your street / flats / area is not covered by a Watch and you wish to start one, you should contact BNWA at http://bnwa.co.uk and complete an application form When you are confirmed as a Watch Co-ordinator, you will receive regular newsletters and updates to distribute to your Watch members.

If preferred, you may be interested to register with Neighbourhood Watch Network (NWN) at www.ourwatchmember.org.uk. This National organisation is designed to create a Nationwide map of neighbourhood watches across the UK.

RVR Community Contributions

In September, 2022, our members voted to contribute £500 to the Queensmead Playground Regeneration project initiated by Cllr Aisha Cuthbert, matching the contribution made by Shortlands Residents Association (SRA). On 23rd January, 2024, following a formal request for payment, the commitment was honoured.

At our members' meeting in January 2024, AFC Shortlands, a community junior football club based at the Queensmead Recreation Ground, requested RVR to contribute towards the cost of a defibrillator for the benefit of the general community. RVR members agreed to contribute £500. Our treasurer, Dave Wiltshire, presented a cheque to the club on Saturday 3rd February.

Along with Shortlands Residents' Association (SRA) and Park Langley Residents' Association (PLRA), RVR have also voted to contribute, starting next year, one third of the costs of the SSNWP meetings (see page 4). This is anticipated to amount to around £45 - £50 per year.
