Proposed RVPS Community Tree Project 2016 Letter of Intent

For discussion Thursday 5th November

2016 Project - roads to be confirmed

The London Borough of Bromley and RVPS will work together on a second Community Tree Project to replace trees lost by disease or storm and provide additional trees to enhance the RVPS area generally. The project timescales will be to plant in January 2016. London Borough of Bromley will:

- Provide a budget of £3,000 (to be confirmed at a meeting of RVPS)
- Arrange for contractors to provide maintenance for one year
- Recommend a list of possible species for residents' to choose (Warren Avenue to be narrow in form because the pavement is relatively narrow)
- Order service maps for possible new tree sites on receiving survey from RVPS
- Draw up a planting confirmation sheet for RVPS to check before instructing the contractors
- Monitor the contractors work
- Liaise as necessary with RVPS

RVPS will:

- Carry out a survey to identify the possible location of new trees for ordering in November bearing in mind that grass verged roads will cost half the price of hard pavements. We are currently considering Warren Avenue, Ravensbourne Avenue and Ravensmead Road
- Canvass homeowners adjacent to possible new tree sites to seek their approval and comments
- Check the planting confirmation sheet complies with home owners approval and comments
- Monitor contractors work
- Liaise as necessary with the London Borough of Bromley
- Pay £3,000 on receipt of invoice from the London Borough of Bromley
