- Saving, against the odds, two oak trees in Crab Hill:

- Campaigning successfully against the redevelopment of Billingford;

Park Restoration Project

A plan to restore many heritage features of Beckenham Place Park and make it more attractive to a wide range of local and regional visitors has received £4.9m from the Heritage Lottery Fund and the Big Lottery.

Lewisham Council will consult current users of the park and the wider public as it develops more detailed plans for future use.

Knotweed

Last year, Glendale, at the request of Clive Lees, very promptly treated a very large patch of knotweed in the following location in Beckenham Place Park:



As expected (as knotweed is very persistent) it now needs treating again and we have asked David Walton, Leisure Manager at London Borough of Lewisham, to arrange this.

This invasive species has been a problem for some time but recently mortgage companies are refusing to lend where properties, or even their neighbours, have this plant in the garden. In other words, if you or your neighbour has it, you may not be able to sell your property. And further, the 'owner' of the knotweed might be legally liable to their neighbours if they are affected in any way. Expert advice is needed to deal with it. It can be recognised by:

- lush green in colour;
- shovel shaped leaves;
- stem is bamboo like in appearance;
- produces white flowers around September or October;
- can grow by 10 cm a day



Glassmill Pond Clean-up

A Meeting was held at Bromley Town Church on 24th June by Thames21 who are managing the clean-up project. They presented a version of the proposed plan which involves creating a flow channel along one side, to reduce the silting problem, and allowing the pond to fill up when water flow is sufficient.
