Being in a smoke free area means that only specified (i.e. smokeless) fuels can be used in a grate and wood burners must be of a 'permitted' type.

#### **NEW APPLICATIONS**

## **General News**

#### **RVPS TREE FRIENDS**

Nine new or replacement trees requested by RVPS tree friends in the monthly action list to Bromley Council have been planted which is very pleasing.

Group work has included more ivy removal from fences, and tidying and planting in the 'Triangle' of common land at the junction of Ravensbourne Avenue and Downs Hill. We shall be planting daffodil bulbs there this autumn.

The main project for 2018 is the planting of annuals in tree pits in Farnaby Road and Madeira Avenue. This will include seeking advice from Mark Byfield, Arboriculture Officer for Bromley Council, canvassing nearby residents and planting on 20<sup>th</sup> May.

#### **ROADS AND TRAFFIC**

Following a dramatic car accident on Farnaby Road, the police have been running speed checks and the Council plan to move the flashing speed indicator to where the accident happened. We continue to lobby the Council about excessive speed but members should feel encouraged to contact our Councillors with concerns. We still await a parking review by the Council of the parking system introduced around Ravensbourne Station. Concern that the lack of use of the pay-by-mobile spaces has increased the speed of cars on Crab Hill seems justified by a recent accident here requiring the Air Ambulance.

#### Lewisham and Catford flood alleviation scheme and Park Regeneration Heritage Lottery Fund scheme
