

# **Planning**

### Always check planning permission!

Homeowners have many rights ('permitted development rights') to make alterations/additions to their property, including structures in the garden. But building outside of these rights and without planning permission can be expensive if it becomes necessary to regularise the position after building. Bromley and Lewisham are known to require demolition of unauthorised structures and there are quite a few of these across the two boroughs each year.



www.planningportal.co.uk is a great source of information.

Sometimes even innocuous changes need planning permission: -

- Decking more than 30cm high
- Fences at the front of a house more than 1m tall
- Sheds over 2.5m tall if within 2m of a boundary
- Many types of driveway

For example, this bin store in Madeira Avenue has been refused permission recently because 'by reason of its size and siting, [it] results in a detrimental impact on the character, appearance and visual amenities of the streetscene'.



There are numerous detailed considerations, so do please check before going ahead with your plans. You can find helpful links on our website.


### Councils don't always get planning law right!

Some of our Lewisham members recently complained to Lewisham Council about a development they were unhappy about. In response, Lewisham refused to take action, arguing that the development was lawful. Members asked us for our opinion and we were able to demonstrate that the Council had applied the law incorrectly. As a result of our intervention, Lewisham is now reviewing the proposal again.

# Heritage under threat at Bromley Civic Centre



Bromley boasts several Grade 2 listed properties at the Civic Centre. Sadly, and rather ironically, Bromley seems to have breached its own planning conditions by allowing the permanent installation of the unsightly roof railings on the Grade 2 Old Palace Building. What's more, the old Ice House (also Grade 2) in the grounds of the Palace has been neglected to such an extent that it is now on English Heritage's 'at risk' register. We hope that Bromley expedites a plan to restore it!

Councillor Rutherford has reassured us that concerns about the Ice House have been fully recognised.

### **Shortlands Village Conservation Area – what's happening?**

The Council is now considering the responses to its consultation as well as determining its 'engagement and sign-off processes... [which] may involve further discussions with local groups such as RVR.' The Council hopes to finalise its plans 'by sometime in the first half of 2021' but we hope that this can be accelerated to protect the area from inappropriate development.

We are also pleased to confirm that the Conservation Area does not in itself prevent many alterations including Solar Panels, but as noted above, ALWAYS check.

#### Tree news

Yet again, an insurance company is alleging without any evidence that a protected tree in the Downs Hill Conservation Area is causing the subsidence of a nearby house. We have been supporting Members to refute this allegation and as a result the insurer has withdrawn their application to fell the tree. Many thanks to Cllr Tickner and especially Cllr Mellor for support here.

In addition to supporting members in this way, we <u>strongly recommend</u> that you do not undertake any tree work unless you are sure you do not need planning permission to do so. In the local area, Bromley either has or is considering issuing 'Tree Replacement Orders' and prosecution at more than one property. You have been warned!

## **Transport Issues**

### Traffic offences – how you can take action

The Metropolitan Police welcomes videos from the public showing evidence of driving offences. As they prosecute most of the offences reported, it really works!

#### **Examples of offences: -**

- Holding a mobile phone while driving (the video must provide evidence of 'communication', not just browsing, but the law is due to become much stricter, so any hand-held use will be illegal)
- Red light jumping
- Speeding (new technology will enable speed to be <u>calculated from video film</u>)
- 'Cutting up'

You can see an example of video being used for enforcement <a href="here">here</a>. Videos can be uploaded to the Police <a href="here">here</a>. You need two minutes of footage before and after the event and the incident must be less than ten days old.

### Traffic problems – have your say

Following a further multi-vehicle crash on Farnaby Road in November, and growing dismay about traffic on some other roads, we have launched a survey specifically aimed at Farnaby Road, Bromley Avenue and Ravensmead Road. We would welcome your views by 28<sup>th</sup> February and we will use the feedback to make appropriate representations to Bromley Council.

### A traffic problem solved

Pedestrians and especially parents with children going to school will have noticed the new crossing in Beckenham Lane between Farnaby Road and Highland Road. It comes with an anti-slip surface, a planter on the exit from Farnaby Rd and, we believe, a 20mph advisory school zone will be introduced to ensure that cars can actually stop in time.

Many thanks to Cllr Nicky Dykes, Council Officer Stephen Oliver and RVR member Parisa Wright who pushed for this safety measure and were instrumental in making this happen with support from local residents and the Valley School community.



## **Community Issues**

### Local couple (Farnaby Road!) help NHS staff through Covid crisis

Seena and her husband Vishal (a doctor at King's) set up the 'NHS Wellness Boxes' project to send boxes with snacks, goodies and toiletries out to very hard-pressed staff members in the Covid and A&E wards of our local and other hospitals. Between March and September, 7,000 boxes were delivered to help doctors and nurses get through very difficult days. Of these Seena packed 1,500!

Seena also raised over £4k on a Just Giving campaign to fund this project – many appreciative thanks to everybody who contributed. The impact of these boxes in terms of the support they provide, both on a physical and emotional level, cannot be underestimated. Indeed, the project was so worthwhile that King's Hospital took it over and now administers it itself. Wonderful!

#### **Environmental Issues**

### **Bromley's Open Space Strategy 2021**

Bromley has just completed a consultation on its draft Open Space Strategy. This caused concern through the use of phrases such as: - "Being brave enough to recognise when open space should be repurposed", and "Identify open spaces that require alteration, investment or reassignment (including development or disposal)"

Subsequently, Cllr William Huntington-Thresher confirmed that 'parks and parkland' were not for sale.

Overall, many residents were pleased to have an opportunity to contribute to the consultation (there were 800 responses) and for this we have Cllr Will Harmer (Chairman, Environment and Community Policy Development and Scrutiny Committee) to thank as without his intervention, we understand, there would not have been a public consultation.

We asked that the Strategy should include a mechanism to ensure Warren Avenue Playing Fields are properly administered by Lewisham

## Ashgrove Road and Shortlands nuisance areas



Residents have been unhappy that a site on Ashgrove Road next to Coral's and opposite McDonalds has become what amounts to a permanent fly-tipping spot. We have complained to Lewisham Council which has reassured us that it is working on an effective solution to the problem.

Residents may have noticed these unsightly cages and other rubbish outside the shops in Shortlands. Both RVR and Shortlands Residents Association have complained about them as they detract from the area (especially as it is intended to be a Conservation Area!) Unfortunately, the Council's power to intervene appears limited although some improvement has occurred after the intervention of Cllr Nicky Dykes. We have just learned that the shop forecourts are actually owned by LBB which may give Bromley much greater powers to manage this area.





A big thanks to all our residents who go out litter picking to create a clean and tidy environment. Please contact us for a free litter picker if you would like to get stuck in as well! Every bit of effort – large or small – makes a difference.



### Wood burners and open fires

New research reported in <u>The Guardian</u> showed that in real life situations, wood burners and open fires release large amounts of harmful particulate matter into the room they are actually in and not just into the external environment. Do be careful and help protect the air we breathe! A <u>further report</u> from Asthma UK and British Lung Foundation Partnership calls for people to use alternative, less polluting heating options if they can and ask politicians to raise awareness of health risks.




In the leaflet, Bromley Council is reminding residents about other messages, including the ongoing pandemic and its anti fly-tipping campaign.
